From the President's desk...



The Suncoast Chapter was awarded *BEST CHAPTER OF THE YEAR* for the 4th year in a row at the FSEA convention last week! Kudos to the members for their support in making our chapter grEAt!!

July marks the beginning the Board's second year in office. This year we are focusing much of our efforts on Goal 2 of the FSEA strategic plan which is educating our members. To achieve this goal we will be putting together a series of 4-hour roundtable workshops available to Chapter members beginning in late summer. Although we still have to work out many of the details, we are planning on a facilitator- lead roundtable discussion on various topics.

Attendees would be given a case study prior to the event to research and the group will discuss and complete the forms associated with the problem. Possible workshop topics may include: Death of a Taxpayer, Non-Profit filing and reporting, Foreign Asset reporting, Small Business Startups & planning, Real Estate Issues, Collections, and possibly a few on small office management such as how to advance to the next level for the sole practitioner & disaster planning. While not eligible as IRS continuing education they would qualify for credit from NAEA. If there is a particular topic you think would work out well for this format please let me know.

In addition we are also considering offering several QuickBooks & Xero workshops to provide some tips and tricks on the software. Attendees would have the opportunity to bring their laptops and their questions.

We have just launched a sponsorship program for the monthly chapter dinner meetings and are actively soliciting for those sponsors who have products that align with our profession. If you have a vendor that might be a good fit please make Laura Vensel, EA or Nichole Morales, EA aware of their information. The presentations will take place during the dinner portion of the meeting and the fees paid will be earmarked for the educational committee budget. It is our intent to use the funds to offset the cost of providing workshops to our members and possibly bringing in outside speakers.

I want to remind you that the Chapter membership dues renewal date is July 1st. This is separate dues from NAEA/FSEA. You must be a member in those 2 organizations to enable you to have membership within our chapter. The cost of annual chapter membership is \$40.

It takes everyone's participation to make a chapter. That said, beginning this year we are asking all members to commit 5 hours of volunteer time as part of their membership in the chapter. This could be helping set up for an event, assisting where needed with a committee, presenting a topic to the group, making phone calls, etc. At the July meeting there will be sign-up sheets available where you will have the opportunity to volunteer your services.

On October 23rd there will be an After Tax (*Extension*) Picnic at Philippe Park in Pinellas which is open to all. The park has a playground, horseshoes and a many other activities including an Indian Burial Mound! We are considering Sonny's BBQ to cater the event.

We had hoped to have credit card processing available for the July dinner meeting as well as a Pay Link option on your emailed membership invoices. We have hit a few roadblocks but still hope to provide that convenience in the near future.

December 8th is the date of our Holiday Party. This year the venue will be the Crafted Plate where we have secured a private room. The restaurant is located in the Marriott Clearwater Hotel at 12600 Roosevelt Blvd.
